



## **The PAX Edutainment Privacy Policy**

The below information explains our Internet privacy policy and the practises our company has adopted, PAX Edutainment reserves the right to amend this policy at any time.

### **The information we collect:**

When you access our web pages, certain technical information is automatically collected. We collect no other information except for the information which you deliberately send us, for example, by filling our application form, or by emailing us your details.

We analyse traffic/access information for site planning purposes and resource management. We reserve the right to use log detail for the purpose of investigation in security concerns or resource management.

Some of our web pages use "cookies." Usually a cookie enables a website to tailor what you see according to the way you entered the site (for example, if you entered via a certain link from Instagram or a blog post, or if you are using a mobile device).

We use aggregate and non-identifying information to better design our website. For example, we may determine that the average visitor typically is a certain percentage of men vs. women applied to our program or an average visitor typically has viewed our website for a certain number of minutes. Nevertheless, we do not gather or disclose information that could identify those specific individuals.

Our web pages may use Google Analytics or other similar services to analyse web traffic to identify the website performance and for design purposes. In such cases, the information described above may be shared with the entities providing the analytical service. We do not control the privacy policies of these entities.

When you choose to provide information about yourself or someone else with us, the information is used by us only to respond to, or to fulfil, your request. We do not share this information with any outside parties, except to the extent necessary to complete the request.

We never share or use the information you provide to us in ways unrelated to the intended purpose and without also providing you an opportunity to opt-out.

We are dedicated to maintaining data accuracy, preventing unauthorised data access, and ensuring the appropriate use of information. We strive to put in place appropriate safeguards to secure the information that we collect online.



### **What is your information used for?**

The information that we collect from you may be used in any of the following ways, in order to function smoothly:

- To process your application to any of our programs
- The email address you provide us may be used to send you information, respond to your queries/requests/any questions and newsletters/blogposts (for newsletters and blogposts sent to your email you may unsubscribe them if required)
- To assist our team with visa processing services
- To assist our team with your host company placement
- To notify next of kin in the case of emergency issues
- To assist our team with medical support
- To comply with local country laws with regards to registration of visitors
- To pre-book necessary services such as accommodation, food, transportation, etc (case by case basis)
- To provide insights on international internships at higher education conferences (pertaining to overall data, rather than individual persons)
- To provide insights on international internships at higher education seminars, presentations or conferences (pertaining to overall data, rather than individual persons data)
- To administer a contest, promotion, survey or other site feature
- To arrange internship placements (company contacts)
- To facilitate university partnerships (university contacts)
- The email address you provide may be used to send you information, respond to enquiries, and/or other requests or questions.

### **Duration we retain your information:**

We keep your personal data providing you have demonstrated an interest in our programs and services within the past three years.
